

Real ID:

- What is it? "The REAL ID Act is a federal law passed by Congress after Sept. 11, 2001, that establishes specific minimum federal standards for state-issued driver's licenses and ID cards to be accepted for certain federal purposes, like entering a federal building or boarding a domestic commercial flight. Enforcement of the REAL ID Act at the card level begins on October 1, 2020. To be considered REAL ID compliant, you must have the required documents on file with the Maryland Department of Transportation Motor Vehicle Administration (MDOT MVA)."
- What does this mean for me? "Even if you have the newly-designed driver's license or identification card, you may need to submit additional documents in order to be REAL ID compliant." You may need to get a new driver's license <u>before</u> the renewal date on your current license.
